1. Information on how to enter forms part of the terms and conditions of entry. Acceptance of the prize is deemed acceptance of these terms and conditions.
2. The promoter is The Royal Automobile Club of Tasmania (ABN 62 009 475 861) of Cnr Murray & Patrick Sts, Hobart, Tasmania, 7000 (telephone number 03 6232 6300 (**Promoter**)).
3. Entry is open only to residents of Tasmania (**Eligible Entrants**), excluding directors, management, employees and their immediate families of the Promoter or Jetset Travelworld Limited (**Jetset Travelworld**) and their related bodies corporate and registered travel companions of employees of the Promoter or Jetset Travelworld.
