


State Election Priorities 2021

About RACT

RACT enjoys a trusted position and extensive market penetration in the community. Over 200,000 Tasmanians are RACT members.

We are the largest and strongest member organisation in Tasmania. Formed in 1923, RACT is an apolitical and independent transport infrastructure, road safety and mobility advocate.

We are committed to supporting and furthering the interests of Tasmanians and we do this through a comprehensive program of consultation, education, awareness and public advocacy.

RACT is represented by senior staff in a number of stakeholder reference organisations in Tasmania and undertakes structured liaison with government and other stakeholder groups.

Nationally, RACT is a constituent member of the Australian Automobile Association (AAA), which represents some 8 million Australian motorists. RACT is a regular contributor to the committees and forums of the AAA.

Internationally, RACT has joined with other Australian motoring organisations as a member of the Fédération Internationale de l'Automobile (FIA) to work on road safety and related issues at a global level.

RACT's advocacy and public policy activity is defined by a series of policy documents developed and endorsed by the RACT Advocacy Committee and RACT Board.

These policies have been informed by history, experience, statistical analysis, consultation, industry knowledge and our members.

Our Priorities



Improved road safety strategies for Tasmania

Tasmania did not reach the outcomes identified under the 2011-2020 National Road Safety Strategy. As we consider the best way to tackle the problem across the next ten years, we must look at best practice options nationally and globally. Tasmanians deserve to be safe on our roads and to do this we must think differently, taking on creative options that bring about real change.



Effective road funding mechanisms

The way in which we fund our roads should be fair and equitable and lead to better outcomes across regional and urban areas.

2021 ELECTION PRIORITY 1

Reduce the number and the impact of road crashes in Tasmania

We are seeking a clear action plan, specifically requesting a review of road safety in Tasmania. Our immediate requests for road safety improvements include:

- Reinvestment of speeding fine revenue into road safety, including the roll out of more advanced speed camera and mobile phone detection technologies.
- A fresh Tasmanian Road Safety Strategy (TRSS), informed by global best practice that is committed to and funded by government.
- Funding for a statewide, interactive RACT road safety education program(s) for metro and regional schools Kinder to Year 12 - \$2.8 million.
- Funding for an RACT nation-leading driver trainer education program to lift the quality and capacity of Tasmanian driver trainers across Tasmania - \$800,000.
- Funding to update and re-launch the RACT driver training and log book app.



2021 ELECTION PRIORITY 2

Development of a clear and effective road funding framework and mechanism

We are seeking a review of the way in which roads and road maintenance is funded to ensure that roads are built and maintained to appropriate standards.

Specifically we are looking for:

- Development of 10-year plans for Tasmania's major roads, with a particular focus on the Tasman Highway and Bass Highway. This must include the provision of long-term funding.
- Introduction of a road maintenance mechanism that results in increased investment in road maintenance programs to improve the long term quality of the Tasmanian road network regardless of ownership.
