Camping Cards

The Camping Card International (CCI) is a useful and widely recognised document throughout Europe at camping and caravanning sites.

The CCI is respected proof of identity that has the same value as a passport for the campsite owner.

A CCI card is a discount card at more than 2,500 campsites throughout Europe. This discount can be as much as 25% in both the high season and low season. If, for example, two adults and two children go camping for fourteen days in France, the discount can be almost 40.00 pounds.

All campers that hold a CCI must read and abide by the Campers Code of conduct as stipulate on the back of the application.

Period of Insurance

The period of this insurance covers claims arising under all CCI issued up to the expiry date of the CCI held by the Club member. Any claim will be handled according to the terms of the contract in force in the year during which the CCI was issued.

This insurance excludes the application of the Laws and any costs incurred in respect of any claim arising in United States of America and Canada or any territory where the Laws of United States of America and Canada might apply.

Insurance Cover

F.I.C.C has taken out third-party liability insurance with English insurance company Miller Insurance Services LLP of London for holders of a CCI. This insurance covers the legal liability for damage and / or personal injury to third parties during camping trips and a stay in a rented accommodation or hotel that is caused by the holder of the CCI and their husband/wife and by those (up to a maximum

of 11 persons) travelling with them in the same private vehicle or by bike. If the holder of the CCI has to temporarily leave his or her travelling companions behind and return home in the course of the holiday, these travelling companions remain Insured.

Camping Card Application

In order to obtain a CCI the following steps must be taken:

- a) Complete and sign an Application for International Camping Card.
- b) Provide the following:
 - Photocopy of applicants Passport (in colour) or Passports where the applicant holds dual passports.
 - Photocopy of current club membership
 - Photocopy of the applicants current drivers licence (in colour)

The CCI cannot be processed until all documentation is provided and all fees are paid to the **Constituent Motoring Club in your State**. Please allow at least ten (10) working days for the completion of the documentation.

CAMPERS CODE OF CONDUCT

- a. Camp only at campsites that are permanently authorised or where permission is given on request (particularly in forests). Give your CCI to the manager to keep during the period of your stay. Follow the camp regulations and those of the local authority.
- b. Do not light a wood fire without permission; do not cause damage to hedges or trees by fire. Before lighting a fire, clear the site of brushwood.
- c. Do not leave any rubbish on the campsite. Dispose of it in accordance with camp rules; if there are no facilities for rubbish disposal, take it away. Always leave the site as clean when you depart as you would like to find it when you come back again.
- d. Pay special attention to questions of sanitation. Be polite. Respect other people's peace and property and do not shock them by your language or by your dress.
- e. Do not disturb the silent hours as published on the site.

As you may be liable for fees incurred through its misuse.
